Who are we?

David Le Poidevin - Interim Chairman

David is the Managing Director of Orion Insurance Management Limited and Foresters Healthcare. He stepped away from CareWatch in July 2023 after serving as our interim chair since November 2021.

Bella Farrell - CareWatch Chair

Bella is Director & CEO at Health Connections LBG and was appointed as our new Chair in September 2023. Bella brings leadership, experience and a collaborative communication style as well as having a depth and breadth of understanding of the needs of service users of HSC in a variety of settings. A key aim of Bella's is to build trust with HSC, encouraging open transparent respectful dialogue which supports others to seek, listen to and respond to the voice of service users, maintaining and strengthening the integrity of CareWatch in achieving its primary aim.

Mike Read - Vice Chair

Mike grew up in Guernsey leaving to join the Royal Air Force in 1987. He returned home in 2000, now flying all over the World as a commercial pilot for AirTours, Dragon Air and Cathay Pacific Airways, before joining Aurigny in 2022. In 2016, as a result of his family's experiences accessing care for a daughter with a chronic health condition, Mike set up the charity Cystic Fibrosis Guernsey. Active involvement in the third sector has led to other roles including being the Health Representative for the Guernsey Disability Alliance (GDA), Chair of Health Equality for All (HEAL), Chair of the Guernsey Cancer Alliance (GCA) and a panel member on Aging Well in the Bailiwick (AWB).

David Inglis - Member

David is currently the Chairman of Age Concern Guernsey whose primary role is to provide focus on issues relating to the community members that require support or guidance.

In recent years, David was the Chairman for Young Enterprise, following ten years as an advisor. He has also served as a past Chairman of PostWatch Guernsey and past President of the Bowmen of Guernsey. He has been a member of the Confederation of Guernsey Industry (CGi) management board and a former Chairman of Guernsey Island Games Association.

Heather Reed – Member

Heather moved to Guernsey in 1998 to take up a post as Consultant Obstetrician and Gynaecologist. She cared for the women of Guernsey for almost 20 years and was also working as Honorary Consultant to the Southampton University Hospital Trust. Her role included the care of victims of sexual abuse and child abuse, and it was during this time she became a Directors of the Guernsey's Women's Refuge.

Since her retirement in 2017, Heather has been elected as a Jurat of the Royal Court and with the outbreak of the COVID-19 pandemic has worked as a vaccinator with the CVC team. Heather's charity work has included fund raising for several local charities and includes work as a volunteer for Health Connections who signpost and assist people to access various services offered to the Guernsey community.

Elizabeth Nye - Member

Elizabeth began her career in 1975 working as a Pharmacist Manager for several independents throughout the Southeast of England followed by several short contracts in the Middle East.

She came to Guernsey in 1984 and worked in all three Island practice pharmacies moving to an independent group in 2001. Elizabeth's major interests are in Health Promotion, encouraging a healthy lifestyle in a holistic manner, incorporating exercise, balanced eating and good mental health.

Jenny Benjamin - Member

Jenny has a nursing and health visiting background. She worked for a number of years for the States of Guernsey Education Department supporting the Personal, Social and Health Education Programmes in primary, secondary and private schools. She was also a Tribunal member on the Child, Youth and Community Tribunal and was aware of the impact that social and health care can have on relationships, behaviour, education and mental wellbeing.

In her work as Lead Volunteer for Health Connections Talking Cafes, she signposts people to the many agencies in the community for support and information. She is committed to encouraging all areas of health and social care to reach out for excellence, valuing their workforce and putting the patient at the forefront of its services.

Molly Edington - Member

Molly has lived in Guernsey since 2014 and has always had a keen interest in local healthcare, with a focus on access to care. As a type 1 diabetic Molly is keen to learn of the experience of other Diabetics, or those with chronic conditions, with accessing and receiving care.

The table above outlines the meetings held in 2023 and summarises the topics discussed. There was a mixture of areas considered which include but are not limited to: recruitment and retention of HSC staff, gastroenterology and orthopaedic waiting lists, mental health, improving community awareness of CareWatch, engagement and collaboration, NICE TAs, ED Charges, the role of The Professional Alliance, CareWatch's mandate and strengthening our relationship with HSC.

The table does not capture all discussion points that have developed during meetings, for example at some meetings members table feedback or questions that have been brought to them by members of the public. This open form of meeting structure allows all members to have an opportunity to provide information and feedback that they have received from the community. This adds value to meetings and provides essential anecdotal evidence of some of the current issues faced in health and social services in Guernsey.

One of the key issues for CareWatch over a number of years has been effective communication with members of the community and HSC. To aid in solving these challenges a focus has been placed on:

- The addition of new panel members.
- The appointment of a Chair, endorsed and supported by HSC, providing an opportunity for renewed leadership, an environment for positive change and action.
- Establishing a clear structure, roles and responsibilities within the panel.
- Appropriate funding allowing CareWatch to fulfil its primary role.
- A fresh website, to establish an independent identity, significantly improve our visibility, accessibility and accountability.
- The addition of an online survey to our new website.

At the time of writing this report, the panel has never been more confident that the changes currently underway will allow us to provide a timely two way independent communication channel between the community and HSC.

During the year panel members, or in some cases CareWatch as a whole, meets with or receives presentations from HSC or outside third party bodies. These allow the panel to gain a better understanding of certain areas of Health & Social Care and in some cases raises concerns or discussion points that CareWatch looks into further.

Relationship with the Committee for Health & Social Care

The Committee *for* Health & Social Care currently provides administration services to CareWatch such as: Circulating documentation for meetings, minute taking and forwarded correspondence between HSC and CareWatch.

To promote efficient communication between CareWatch and the Committee *for* Health & Social Care, CareWatch extends an open invitation to all HSC deputies to attend any of their meetings in person or virtually. No HSC deputies took the opportunity to join us during 2023. However, since November, the CareWatch Chair has attended HSC's monthly Corporate Management Team meetings, allowing us to voice current concerns directly to service leads.

CareWatch continue to actively strengthen their relationship with HSC whilst maintaining its independence, to provide a timely, open and transparent communicative bridge between HSC and the users of health and social care services.

Summary

In conclusion, CareWatch has discussed and worked on a number of significant topics in 2022 and 2023 which are yet to have an impact on our community and the services health and social care provide. These include the Primary Care Review, with CareWatch commissioning a survey to understand the current access and utilisation of primary care services, which allowed the community to voice their opinions of the services on offer. It is hoped the findings from the survey will be used within the Primary Care Review, which is being undertaken jointly by the Committee for Health & Social Care and the Committee for Employment & Social Security. We continue to actively monitor this work-stream and what it might mean for service users.

In 2023 HSC asked CareWatch to co-ordinate engagement and provide feedback on the experience of members of the community, and their families, who have been prescribed a NICE TA drug or treatment and share its findings with the Committee. This work complements a comprehensive clinical and financial analysis conducted by Solutions for Public Health, an organisation independent of HSC.

When the Committee recommended the introduction of NICE TAs in January 2020, it did so on the basis that, among other things, the treatments would likely improve patient outcomes and experience by reducing uncomfortable or painful side effects and adverse events. Since that time we know hundreds of new drugs and treatments have been made available to patients at a cost that was far below original estimates to potentially thousands of patients. In August CareWatch submitted the community feedback we received with our comments and observations, and wait now for this work-stream to progress and the proposals that will follow.

During 2023, there has been a continual focus on the need to strengthen the panel and an awareness of the need to raise the profile, visibility and role of CareWatch within our community, communicating more clearly service user needs, issues and concerns, providing positive challenge where necessary.

As we move into 2024 the lack of a clear direction from, the Tax Review and recent Funding and Investment Plan, is likely to impact on the resources available to the Committee *for* Health and Social Care and the way services are delivered. The importance of the role CareWatch plays and the challenge of ensuring the public have an independent voice within the health and social care sector has never been greater.
