## Who are we?

#### David Le Poidevin - Interim Chairman / Member

David is currently the Managing Director of Orion Insurance Management Limited and Foresters Healthcare where he specialises in business and product development, insurance market research and management consultancy.

David is specifically focused on island healthcare insurance requirements and ensuring Bailiwick Residents have affordable and accessible primary care services.

David was appointed Interim Chairman in November 2021.

## **Katherine Adam – Member**

Katherine has been a volunteer with Citizens Advice for over 15 years, advising people of their rights and responsibilities and helping them find ways to deal with problems in many areas of life. Before moving to Guernsey in the 1980's, Katherine was an Educational Psychologist in Scotland, working with children and schools in Glasgow.

# David Inglis - Member

David is currently the Chairman of Age Concern Guernsey whose primary role is to provide focus on issues relating to the community members that require support or guidance.

In recent years, David was the Chairman for Young Enterprise, following ten years as an advisor. He has also served as a past Chairman of PostWatch Guernsey and past President of the Bowmen of Guernsey. He has been a member of the Confederation of Guernsey Industry (CGi) management board and a former Chairman of Guernsey Island Games Association.

#### **Heather Reed - Member**

Heather moved to Guernsey in 1998 to take up a post as Consultant Obstetrician and Gynaecologist. She cared for the women of Guernsey for almost 20 years and was also working as Honorary

Consultant to the Southampton University Hospital Trust. Her role included the care of victims of sexual abuse and child abuse, and it was during this time she became a Directors of the Guernsey's Women's' Refuge.

Since her retirement in 2017, Heather has been elected as a Jurat of the Royal Court and with the outbreak of the COVID-19 pandemic has worked as a vaccinator with the CVC team. Heather's charity work has included fund raising for several local charities and includes work as a volunteer for Health Connections who signpost and assist people to access various services offered to the Guernsey community.

#### **Lindsay Jefferies - Member**

Lindsay is currently the Managing Director of Island Global Research, a Guernsey-based market research company. Before joining Island Global Research, Lindsay was a Lecturer in Health Economics at the London School of Hygiene and Tropical Medicine (LSHTM). She worked in the Faculty of Public Health for ten years and during that time completed a PhD in Health Economics.

Lindsay's interest in public health and practice started in 2004 when she was working for the UK Department for International Development and led research on the retention of nurses in Malawi. Her subsequent academic research focused on the design, implementation and evaluation of interventions to improve health service provision in low-income countries. As an economist, her role was often to help identify structural and process barriers to health care, understanding provider and patient behaviour, and to identify cost-effective solutions. Since moving to Guernsey she has been involved in several local studies, including the Guernsey and Alderney Wellbeing Survey 2018, a GP patient satisfaction surveys and survey on economic and social impact of COVID-19 on people living in Guernsey, Jersey and the Isle of Man.

#### Natália Jopling Tanser – Member

Natália was born and educated in Portugal before completing her secondary education in Guernsey.

Natália graduated from the University of Southampton with a First-Class Honours Law degree and during her final year at University she took a particular interest in Health Care Law.

### **Elizabeth Nye - Member**

Elizabeth began her career in 1975 working as a Pharmacist Manager for several independents throughout the Southeast of England followed by several short contracts in the Middle East.

She came to Guernsey in 1984 and worked in all three Island practice pharmacies moving to an independent group in 2001. Elizabeth's major interests are in Health Promotion, encouraging a healthy lifestyle in a holistic manner, incorporating exercise, balanced eating and good mental health.

Table two outlines the meetings held in 2022 and summarises the topics discussed. There was a mixture of areas considered which include but are not limited to: recruitment and retention of HSC staff, mental health, community engagement, primary care, Professional Alliance, ID badges, CareWatch's mandate and many more areas.

The table does not capture all discussion points that have developed during meetings, for example at some meetings members table feedback or questions that have been brought to them by members of the public. This open form of meeting structure allows all members to have an opportunity to provide information and feedback that they have received from the community. This adds value to meetings and provides essential anecdotal evidence of some of the current issues faced in health and social services in Guernsey.

One of the key challenges for CareWatch in 2022 had been effectively communication with members of the community. To aid in solving these challenges, during the year a large focus was placed on:

- Updating the CareWatch website;
- Governance documents such as the Mandate, Terms of Reference and Data Protection documents; and
- Ensuring that appropriate methods of communication with CareWatch are clearly signposted.

At the time of writing this report, the panel is satisfied that the above items have been actioned and this has aided in receiving and issuing communications to third party organisations and members of the Community more quickly and clearly. This in turn aids the panel in fulfilling its purpose.

During the year panel members, or in some cases CareWatch as a whole, meets with or receives presentations from HSC or outside third party bodies. These allow the panel to gain a better understanding of certain areas of Health & Social Care and in some cases raises concerns or discussion points that CareWatch looks into further.

## Summary

In conclusion, CareWatch has discussed and worked on a number of topics over the year with one of the more significant items being the Primary Care Survey which was commissioned by the panel to understand current access and utilisation of primary care services across the community and allow the community to voice their opinions on primary care. It is hoped the findings from the survey will be used by the Primary Care Review, which is being undertaken jointly by the Committee *for* Health & Social Care and the Committee *for* Employment & Social Security.

In 2023, the focus for the first quarter is re-strengthening CareWatch by recruiting a number of members, thus adding more knowledge and experience to the panel. CareWatch will continue to discuss process on the Primary Care Review, and the ongoing challenges with staff recruitment and retention. Other areas of focus will be firmed up once the outcome of the Tax Review is known, as this is likely to impact the resources available for the Committee *for* Health and Social Care.
